CEO Barton reported on the recent AZA Zoo Directors Retreat held in Washington, D.C. he attended. CEO Barton stated there would be an Architect/Master Plan review committee meeting in June.

Report by Director of Finance and Administration: Mr. Goldman reviewed the financial statement with the board.
