**Discuss and consider minutes:** Director Richards made a motion to accept the minutes as written. Director Templeton seconded. All in favor. None opposed. Motion carried.

**Chair Report:** Director Dougherty stated he and CEO Barton had recently attended a meeting chaired by a group of local philanthropists to co-op services for non-profits.

**CEO Report:** CEO Barton reported for Mr. Poeschel. CEO Barton stated the Environmental Impact Report is on track and will be going to the public soon. Fresno Chaffee Zoo Education Director, Adrienne Castro reviewed the purpose of the grant with the board. Director Richards made a motion to accept the resolution as read. Director Templeton seconded. All in favor. None opposed. Motion carried. Resolution signed.
