**Chair Report:** Fresno Chaffee Zoo Corp Board Chair Dougherty deferred his report on the Roeding family meeting to CEO Barton. Director Dougherty requested with the Board in agreement that CEO Barton continue the contact with the Roeding family.

**CEO Report:** CEO Barton stated the August attendance was ahead of 2008 and was one of the busiest in many years. CEO Barton stated the Zoo Tax Authority approved funding to move ahead with the design of our Sea Lion exhibit and the additional funding for the environmental impact report. CEO Barton stated the purchase contract for the stingray bay exhibit has been signed and the zoo will take over the operations on September 14, 2009. CEO Barton stated this will save on operational expenses for the popular exhibit. CEO Barton reported he, Fresno Chaffee Zoo Board Directors Dougherty and Manning-Cartwright met with the Roeding family attorney Mr. R. Harriman. A variety of subjects were discussed and though no issues were settled all agreed to continue discussions. CEO Barton stated the consultants, staff and the City of Fresno staff have been working diligently to move the environmental impact report along.

**Report by Director of Finance and Administration:** Mr. Goldman reviewed the financial statements with the board. Mr. Goldman stated the Finance Committee would be meeting soon.
